

### LEO CASAS, AIA, NCARB, BRAULIO CASAS ARCHI-TECTS, PA

Architect Leo Casas has a passion for the design and implementation of well-crafted traditional and classical architecture. His firm, Seaside-based Braulio Casas Architects, PA, specializes in designing towns, neighborhoods and buildings of all types. Casas says his work is based on the craft of building, whether it's civic, commercial or residential. With each project, he and his team focus on key principles of architecture; namely urban appropriateness, architectonic integrity and beauty, and keep them consistent to express the structural quality of the building. They use local materials when possible and incorporate aspects of sustainability into every buildings.

From 2005 - 2009, Casas served as Town Architect for Seaside, overseeing the design and construction of the expansion of Seaside's Town Center. The project is ongoing, and Casas predicts it will ebb and flow to meet the needs of the community throughout the life of the town. Today, Braulio Casas designs a variety of buildings along 30-A, as well as other locations.

Casas says there are special considerations when designing within a planned community like the towns along 30-A. First, the architect and client must take into account the location of the project and its overall context within the town plan. Casas refers to this process as having "good urban manners" and says his clients understand


Growing up in Northwest
